Conditions of use: Intended to come into repeated short-term contact (up to one day) with

all kinds of food, stored under refrigerated conditions or at room up to

30°C.

Migration results are based on the assumption that at least 1000 g food

is in contact with one Pressure pump sprayer.

- Samples of the products mentioned above were delivered by post mail on 16.05.2025 and 22.05.2025;

- Composition of the products mentioned above was delivered by e-mail on 17.04.2023 and on 14.05.2025;

- Recipes of used printing inks were delivered by e-mail on 12.05.2025;

- Certificates of conformity and statements of raw material producers for the used polymers were delivered by e-mail on 03.07.2024;

- Confirmation that there are no changes in the recipe, the raw materials (incl. the suppliers) or the production processes by e-mail on 24.03.2025.

Migration tests:

Specific migration and screening investigations in accordance with fRegulation (EU) No. 10/2011 and its amendments on plastic materials. Sensory properties are not part of the certificate.
